BBPI HOST HIGH SCHOOL AGE KIDS WITH INTEREST IN THE EARTH SCIENCES THROUGH A DREXE UNIVERSITY-SPONSORED PROGRAM CALLED DESLA (DREXEL ENVIRONMENTAL SCIENCE LEADERSHIP ACADEMY). ALL FOSSILS ARE BROUGHT BACK TO OUR FOSSILS FOSSIL PREPARATION LABORATORY AT THE ACADEMY OF NATURAL SCIENCES IN PHILADELPHIA, PA. THE FOSSILS ARE THEN PREPARED, SONSERVED, AND USED FOR EDUCATION THROUGH OUR OUTREACH PROGRAS
